DUE TO CORONA VIRUS PANDEMIC**

This agreement is between the Participant listed above (Participant Name) and the Poinsettia Center For the Arts (PCFTA).

- 1) Participant is NOT to come to facility if sick. If any of the below symptoms are present either before coming to facility or at the facility, Participant will notify appropriate production team contact (see item 13 below) immediately:
 - a. Fever or chills
 - b. Cough
 - c. Shortness of breath or difficulty breathing
 - d. Fatigue
 - e. Muscle or body aches
 - f. Headache
 - g. New loss of taste or smell
 - h. Sore throat
 - i. Congestion or runny nose
 - j. Nausea or vomiting
 - k. Diarrhea
- 2) If participant has symptoms they are to immediately leave facility or wait in quarantine area until they may be picked up.
- 3) Participant may only return to facility if they have been symptom free for 14 days or have a negative CORONA VIRUS test result.
- 4) If Participant Tests Positive for CORONA VIRUS, Participant agrees to provide appropriate production team contact (see item 13 below) with names and dates of contact for all other staff, Participants, vendors, patrons and individuals having relationship with the PCFTA with whom they have been in contact within 14 days of their positive test results.
- 5) Upon arrival at facility, participant will be interviewed to insure participant is symptom free and has no fever. If participant has not taken temperature prior to arrival, staff will take participant temperature before admittance.
- 6) Upon arrival at facility, participant will sanitize and/or wash hands thoroughly and will re-sanitize and/or wash hands as necessary. Participant will refrain from touching eyes, nose, mouth and face and any time with un-sanitized/unwashed hands.
- 7) When at facility, Participant will maintain a minimum social distance of six feet at all times.
- 8) When at facility, Participant will wear a mask covering nose and mouth at all times
- 9) Participant is required to provide their own mask and will not be admitted without proper face covering.
- 10) Participant has reviewed the "Safe Reopening Plan" and agrees to adhere to it.
- 11) These conditions are temporary and in response to the CORONA VIRUS Pandemic and may be changed as required by Federal, State, County, Local Government, and/or PCFTA.
- 12) While the Star Theatre and its staff are adhering to all Federal, State, County and City guidelines to prevent the spread of CORONA VIRUS, there continues to be risks of exposure to CORONA VIRUS and other diseases in any public gathering. Initial studies indicate risks may be greater with activities like singing. You agree to assume all risk associated with a group activity during this time. You and your family's compliance with all guidelines is required to reduce risk to you as well as all others participating.
